The Criteria of participation:

The first investment conference in northern Syria

The Participation in research and scientific papers at the Conference :is subject to the following criteria

1

Scientific research is subject to the following criteria:

The authenticity of the research and its non-publication or presentation in another context. - Submission by the researcher is an implicit and explicit acknowledgement of the authenticity of the research and is responsible for it

.The research should align with one of the conference themes -

The researcher will initially provide a summary in Arabic with a maximum of 500 words, with atleast 5 keywords, including the search title (Traditional Arabic, font 16) and the name of the researcher as shown in the conference certificate and official papers (bold font 14) and the institution to which it belongs, if any (bold font 14). The summary board shall be in a normal font .14 and single line spacing with a biography of the researcher accompanied by a photograph

The research must be presented according to the form published on the conference identifi- - .ers

The summary and research must be submitted according to the dates announced on the conference identifiers

Participation in a pioneering initiative or success story:

The idea of the initiative or success story is presented according to one of the appropriate .presentation methods

in northern Suria

Mechanism for participation in the Conference:

- 1. Researchers will be notified upon receiving the summaries of their research through their email
- 2. Researchers will be informed of the acceptance of their participation in the conference after submitting their research abstracts and presenting them to the scientific committee. Upon receiving the complete research, it will be peer-reviewed, and any required revisions will be communicated. Participating researchers are expected to make the necessary revisions as approved by the scientific committee
- 3. Acceptance of working papers submitted by some investment activists and representatives of organizations and research centres that do not require the fulfilment of scientific research requirements.
- 4. The languages accepted for presentations and research at the conference are Arabic, Turkish and English.
- 5. Participants receive participation certificates from the University of Aleppo and organizers as well as the conference portfolio.
- 6. Distinguished research will be published in refined and internationally numbered scientific journals if the requirements for scientific publishing are met.
- 7. The first page of the search should contain the title of the search, the name of the researcher in Arabic and English, or researchers, the employer, the address, the email, and the history of the search. In order to ensure the confidentiality of the arbitration process, the name of the researcher or researchers must not be mentioned at the centre of the research, or any indications that reveal their persons, and when the researcher or researchers wish to thank those who have contributed or assisted in the completion of the research, this shall be on a separate page.
- 8. A summary of the search must be provided in Arabic not more than 500 words, and a summary in English not more than 200 words. Each summary shall be on a separate page. Each summary shall contain a search address, and 5 keywords shall function in Arabic and English without mentioning the names or data of the researchers.
- 9. Number of search pages not exceeding (30 pages) including references, tables and formats, excluding supplements.
- 10. Typing patterns and formats are as follows: page size (4 single, minimum margins of 2.5cm) for both top and bottom and sides of the page, including margins, references, extracts, tables and supplements)
- 11. Writing Style: Traditional Arabic 14 font size for Arabic language, font size 14 Times New Roman for English language.
- 12. If the researcher uses a data collection tool, he/she must provide a complete copy of that tool, attached to the publication request.
- 13. The research sent must include all the requirements of scientific research.
- 14. References and sources are documented both in the search and in the reference list, whether English or Arabic, as well as quotations from websites, pages, multiple informational (websites), or e-books in accordance with the American Psychological Association sustem.
